ARTIST INFORMATION

The Crescent City Rotary Club presents the 3rd Annual Arts and Crafts Competition, allowing for the enhancement of one of North Central Florida's most successful and well attended event. The Catfish Festival is in its 39th year and growing. This year the Festival has added a new program encouraging local Artist as well as artists from around the area. Awards will be presented and we hope to present a high profile venue for artists to receive critical review, recognition and feedback.

RULES and PROCEDURES

- Registration will take place:
 - **Friday, March 30, 2017 from 12:00 noon - 4:00 p.m.**
 - **Saturday, April 1, 2017 between 7:30 a.m. - 9:00 a.m.**
- Works of art will be submitted at the Portico located at the North side of Eva Lyons Park. (Look for Signs)
- This is a family Festival please note that all art work must be suitable for viewing by all ages. This event embraces all rules of display at the Catfish Festival.
- All work submitted must be original and handcrafted by the applying artist, not while under academic supervision.
- Work from The Artist may enter more than one category and must include a separate jury fee and Entry Application for each category
- The Artist may submit up to two pieces per category
- **Jury FEES**
 - **\$20 per category for Artist not exhibiting at the Catfish Festival**
 - **\$10 per category for Artist exhibiting at the Catfish Festival**
 - **An Exhibit space for Artist participating in the Juried show will be reduced to \$55.00 per exhibit space.**
- In the event less than three (3) entries are received into any category the Category will be included into the remaining Category for consideration.
- Judge reserve the right to adjust Categories as necessary
- Insurance is the responsibility of the artist. The Crescent City Rotary Catfish Festival and/or Volunteers accept no responsibility for theft or damage caused during transfer or display of art.

JUDGING

Judging will begin Saturday, April 1, 2017 at 9:30 a.m. until 12:30 noon or until Judging is complete.

- Judging will be accomplished by select individuals to include, an Art Educator, recognized or displaying Artist (NOT PARTICIPATING IN THIS SHOW), or an Art Administrator.
- Upon application artist numbers will be assigned and names separated from artwork to avoid unintentional favoritism or bias.
- Each entry will be scored on
 - Strength of composition
 - Competence and use of materials
 - Originality of presentation
 - Clarity of artist comment
